INSURANCE/PROPERTY: Provides for depopulation of the Louisiana Citizens Property Insurance Corporation by domestic insurers via reinsurance

AN ACT

2 To enact R.S. 22:2314.1, relative to the Louisiana Citizens Property Insurance Corporation; 3 to authorize a policy take-out program for domestic insurers via reinsurance; and to 4 provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. R.S. 22:2314.1 is hereby enacted to read as follows: 7 §2314.1. Additional policy take-out program via reinsurance 8 A. In addition to the policy take-out program authorized by R.S. 22:2314, 9 but notwithstanding its provisions, in order to facilitate the depopulation of the 10 corporation's policies and remove this state from the residential and commercial 11 property insurance business, the corporation is hereby authorized to transfer 12 residential and commercial property insurance policies to domestic insurance carriers 13 licensed to write property insurance in this state via reinsurance of those policies to 14 be taken out of the corporation. The reinsurance may be facilitated by property 15 insurance companies domiciled in this state and licensed by the Department of 16 Insurance. 17 B. The purpose of this Section is to depopulate the corporation of as many 18 property insurance risks as can be transferred via reinsurance. It is the intent of the legislature that the corporation not compete with the private insurance market in the 19 20 state of Louisiana. This Section is designed to facilitate the transfer of risk from the

**Abstract:** Authorizes the La. Citizens Property Insurance Corporation (La. Citizens) to transfer residential and commercial property insurance policies to domestic insurance carriers licensed to write property insurance in this state via reinsurance.

<u>Proposed law</u>, in addition to the policy take-out program authorized by <u>present law</u>, but notwithstanding its provisions, authorizes La. Citizens to transfer residential and commercial property insurance policies to domestic insurance carriers licensed to write property insurance in this state via reinsurance of those policies to be taken out of the corporation. Provides that the reinsurance may be facilitated by property insurance companies domiciled in this state and licensed by the Department of Insurance (DOI). Specifies that <u>proposed law</u> is designed to facilitate the transfer of risk from La. Citizens to the voluntary insurance market, and that La. Citizens and DOI are hereby given broad latitude to effectuate these reinsurance programs with all deliberate speed in order to achieve the intent of <u>proposed law</u>.
